- Jason Blankenagel gave an update on the Pleasant Valley Construction the first section of pipe are fused together and lot of it is backfilled, PRV Vault is installed but they haven't place the lid yet, subsurface investigation is finished along Parriette Road and has started along Tower Road. The construction progress is 10% done.
- Will need to have an encroachment agreement with Basin Irrigation.
- ROW Mapping in GIS is 10% completed.
- There has not been any change orders and there will be approximately \$900,000 money left on the construction. Could use the money on East of Myton, Independence Water System or the Pump Station upgrade.

Manager Report:

 - a. There are more requirements like an assembly test, replace or update at least 10 meters. What people have in their yards, stock water etc., and dual check meters?
- It was approved that Paul Percival would be the proxy for JWID Dry Gulch water shares this year.
- Techris Design support would be \$145.00 a month for all computers for one hour.
- Fire Hydrant Water: Right now we are charging \$7.50 per thousand do we raise that rate up 14% like the rest of the water. It would make the cost \$8.55 if we go straight across the board. The Board said to clean up the policy and raise the rate to \$8.55. After Kinder Morgan gets through using the fired hydrant water then we will start with the new price.

Property Discussion Update:

a. Dusty Monks said the he had called and talked to the attorney Gayle McKeachnie about taking out the lessee in the contract and Gayle McKeachnie said that we could not take it out of the contract. After talking to Gayle McKeachnie, Dusty Monks called and talked to Curtis McCormick. Curtis McCormick said that he was withdrawing his bid because he could not get the loan with a lessee in the contract. We have a contract for four years on the land lease. We are back on the drawing board do we keep it or sell the land?
