The pipe has already been purchased. Need to get it done this fall because in the spring the water will be too high.
 - a. Need a letter stating the rating of the pipe, UDOT rated culvert for emergency vehicles and time
 - b. If Wyatt Griffith wants the culvert moved to a different location, then they would pay the difference. Wyatt Griffith will let Dickson Taylor know by Friday or Monday. Since we are out of contract, we will need to extend the contract date.

- Dickson Taylor went over the fee schedule on cost of expenses on operating, maintaining, depreciating, replacing rebuilding etc.
 - a. Monthly base fee and standby fee on connection that are not using water.
 - b. We need to get a fee schedule set up so that we can have a policy for it.
 - A. It will be the Board's responsibility to be ready for December Board Meeting to review Fees.

Utility Financial Assistance:

The papers from Department of Workforces were filled out, signed, and mailed to Lori Page the
Water Assistance Program Specialist in Salt Lake City Utah. Dickson Taylor told the Board we did not
sign up to have access to the portal. There is a flyer on the board telling anyone that is interested in
utility assistance what they need to do.
