- a. Jason Blankenagel went over the Pleasant Valley Construction. The construction is 85% complete. There are some pressure issues at the end of Tower Road. The tie in to the 2-inch line there is a blockage somewhere restricting the flow.
- b. The fencing replacement has been turned over to the landowners.
- c. Duchesne County Road Department agreement for replacing overlay over 135000 South. The County will pay half of the overlay \$30,156.45 and will only require 5 ½-inch total of repaving on the North Lane.
- d. The Booster Station is under the scope on the CIB application. The total amount including amendment #1 is \$401,064.95. Weldon Construction is good with the price if JWID provides materials. Sunrise will get the design wrapped up in the next couple of months.

- a. They understood that JWID would have ten shares of Class D water that would be available this year. They wanted to be able to use the water shares Terry Scholes wanted a couple and Curtis McCormick wanted the rest. The Board told them that they would be discussing them in the meeting and then they would let them know what they decided to do.
- b. Dry Gulch Irrigation Company water shares (stock) that are going to be leased or transferred needs to be done before the first of March. (Article XXVII) It is after March so there will be no water transfer from one lateral to another so the water shares will need to stay in this private 4000 East lateral.

1. MINUTES:

2. REPORTS:

Financial Reports:

 Operational Budget Report was handed out for Board Members to look over. A copy of the Vender Register was handed out on checks that were written for April 2022. It was moved by Drew Eschler to adopt the financial report, second by Paul Percival all approved. (Drew Eschler yes – Paul Percival yes – Daniel Crozier yes – Dean Brough yes)

Manager Report:

- Dickson Taylor talked about having a policy where the landowner would have the contractor install
 the meter. JWID would charge a fee for the tapping, inspection, and meter. The price on parts is
 changing all of the time and JWID is taking a loss on the hookup fee. By doing this it would take the
 liability away from JWID. They would have to follow JWID spec and have it past off by having JWID
 do an inspection on the installation.
 - A. The Board said to do some work on a policy and make up a list of contractors that could be used to install the meters.
- We have replaced five or six of our valves on the old River Road and the Duchesne County Road
 Department is extending the road shoulder out. It means we must raise or lower our valves so that
 we can get to them. The Road Department does not always due BlueStakes so they are always
 covering our valve/meter boxes with dirt or asphalt.
 - A. Drew Eschler will talk to Roger Ames to see what we can do.
- East Duchesne rate is \$1.35 per thousand, 10% water loss and 5 cent Wheeling fee. Do we raise their
 rate to match the rest of the system? The Board said to charge them \$1.80 per thousand and not
 charge them the water loss and wheeling fee.
- Backhoe has 764 hours it is eight years old; do we want to upgrade to a new backhoe? The new backhoe will cost \$128,861.00 and trade in for the old backhoe will be \$70,000.00. The cost of the new backhoe would end up costing JWID \$58,861.00. We have \$70,000 in the backhoe saving account.
- Bike Shiner wants the same agreement as the one house free water for the purchase of the land where the tank is setting.

Health Insurance:

- The Health and Dental insurance will be going up 5.8% and Dental is going up 1.0%. The Benefits Selection Form deadline is May 27, 2022. Open enrollment period closes June 3, 2022, and the new plan begins July 1, 2022.
 - A. The Board said to keep things the way they are this year.

Property Discussion:

 Jason Blankenagel, Sunrise Engineering said that they are working on permits for the access across the gulch to the property.

Hiring Personnel:

- Copies of all resumes were handed out to the Board to look at. Jim Smart told the Board that he had
 interviewed four of the people that applied. Each of the Board gave their opinion of who they liked.
 Jim Smart told the Board that he wanted to interview three more. The Board said that they would
 like to do the final interview with the top three.
 - A. It was decided to do a special meeting on April 24th to do the interview.

 It was motioned by Daniel Crozier to swamp the backhoe out with the Century Equipment Company quote \$58,861.00 for a 580 SN T4F backhoe, second by Dean Brough all approved (Drew Eschler abstain – Paul Percival yes – Daniel Crozier yes – Dean Brough yes)

- It was motioned by Drew Eschler to lease the ten (10) shares within the private 4000 West lateral and upon this irrigation season. A \$50.00 minimum per share plus the water assessments due upon awarding of the contract bids will need to be into the office May 23rd by 3:00 p.m., second by Paul Percival.
