VISITOR: Jason Blankenagel & Curtis Shawcroft, Sunrise Engineering

- Jason Blankenagel gave an update on the Pleasant Valley Construction the first 21,345 ft of pipe is installed and backfilled. The first 20,000 ft passed pressure and BacT testing and is now in service. Change order for adding a stainless-steel ladder to the PRV Vault. (\$785.00) Mobilization is 75% completed and the construction is estimated at 66%.
 - a. There will be extra money left in the construction it could be used to replace the smaller lines in the Independence system.
- Jason said we have been working to get John Price annexed into the system.
- You need to do get an Impact Fee analyst done we could give a proposal cost on getting the Impact fee study done. After it is done then you would know if you can charge an impact fee on connection that have been bought and never been installed.
- GIS Row mapping is about 1/3 done. JWID could also put the Lead & Copper on the GIS because of the new law where you must verify that lead pipe does not go all the way to the house.

VISITOR: Bobby Drake

- Bobby Drake has twelve lots that he bought from Ryan Ross that have been sub-divided at 1133 West Cobble Hollow Drive. Bobby Drake was wondering if he could buy 4-inch pipe and have JWID install the line.
 - a. When Bobby Drake attended Board Meeting July 9, 2020, he was told that he would need to loop the line.
 - A. Dickson Taylor said that with a 4-inch line he did not think it was critical to loop the line. With twelve lots they would use the water before the water went stagnant.
 - B. The Board ask Jason Blankenagel to run the water model to see if a 4-inch waterline would affect the line on the other side of the road from Bobby Drakes Sub-Division.

VISITOR: Jeff Baker and Troy Gadd, Jones & DeMille Engineering

 Jeff Baker and Troy Gadd came in with a bid to survey the loka Tank to find out if it is in the right spot and do a descriptive easement with Gibb Preston all the way to the tank.

VISTOR: Wayne Robb

- Wayne Robb would like a waterline ran to his feedlot. Dickson Taylor told the Board that Todd Moon has
 done something to the meter when he severed the line to Wayne Robb feedlot it was full of snow the
 Radio is cracked and antenna is broke.
- The Richens has withdrawn from the idea of upgrading the line to there place. If we take a 4-inch line to Wayne Robb's feedlot it would benefit the line 10%. The Board went over the different type of pipe and cost and which side of the road to install the pipe. There would be approximately 1200 feet to Wayne Robbs feedlot.
 - a. The Board told Dickson Taylor to communicate with Wayne Robb to let him know that they needed to do some investigating to find out the best place to take the line.

 - A. Jason Blandenagel said that he would have the design amendment finished by May and he would bring the contract amendment to the next board meeting.


