- Ledge Lane Booster Station Upgrade:
  - a. AIC Scada proposal: \$3,792.77 for the pump station and tank control and \$25,000 for software and setup. (\$68,792.77)
  - b. SCI Scada proposal: \$54,987.43 for the pump station and tank controls and \$24,805.36 for software & setup. (\$79,792.79)
